The Consulting Services (the services) is to provide **INTERNAL AUDITOR f .**

The Project Director, Andhra Pradesh Disaster Recovery Project (APDRP) invites eligible Chartered Accountants / Firms to indicate their interest in providing the Service.

The short listing Criteria are:

1. Organization Establishment
2. Capacity to handle such Assignments.
3. Financial Capacity for the last 3 years.
4. Similar experience over the last 5 years.
5. Experience in External Aided Project during the last 5 years.

Expression of Interest (EOI) must ; include the following documents duly signed by the authorized person with seal/stamp.

- Introductory letter on letter head (with complete contact details-name of contact person, mailing address, telephone, cell no, fax, e-mail etc.) explaining as to how the firm is best to deliver the task.
- Registration details of the firm. Sister concerns or subsidiary firms have to submit certification from their mother companies.
- Organization profile.
- Audited financial statement for the preceding three years.
- Short note on the similar projects implemented by the consultancy firm pertaining to the short listing criteria with completion certificate from clients.

The EOI should contain sufficient supporting documents duly attested by the authorized person to substantiate the claim of the consulting firm towards qualification as per the short listing criteria mentioned above. Every page shall also be signed by authorized person with the stamp. It is informed that work orders shall not be treated as experience.

The interested Consultants shall comply the guidelines in para 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers dated January 2011 and revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. Such associations must be clearly stated as either sub-consultants or Joint Venture in the EOI with supporting documents.

A consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the APDRP, Operational Manual ([http://www.apdrp.ap.gov.in/pdf/oper\\_man.pdf](http://www.apdrp.ap.gov.in/pdf/oper_man.pdf)).
