

If last day of receiving tender or the day tender opening becomes paralysed due to any un-foreseen reason(s)/holiday then the next government working day will be the last day of receiving tender or the day of tender opening.

The rate of minimum fee for auditing of the account (SPMRM, FY- 2016-2017 to 2018-2019) is Rs. 10,000/- (Rupees ten thousand) only.




