8.3 Supporting Documents for Technical Evaluation

9. Submission of Bids

The Technical Proposal shall be placed in a sealed envelope clearly marked "Technical Proposal". The original Financial Proposal shall be placed in a separate sealed envelope marked "Financial Proposal". The envelopes containing the Technical and Financial Proposals shall be placed into an outer envelope and sealed.

10. Selection Procedure

- a) A Committee constituted by the Department will carry out a detailed evaluation of the proposals received by it in order to determine whether they are substantially responsive to the requirements set forth in the Proposal. In order to reach such a determination, committee will examine the information supplied by the Applicants, and shall evaluate the same as per the eligibility criteria specified in this EOI. Inability to submit requisite supporting documents/ documentary evidence, may lead to rejection.
- b) The decision of the Committee in the evaluation of responses to the proposal shall be final. The Committee may ask for meetings with the Applicants to seek clarifications on their proposals. No correspondence will be entertained outside the process of negotiation/discussion with the Committee.
- c) Each of the responses shall be evaluated as per the criterions and requirements specified in this document.
- d) Selection will be made on the basis of least cost method.
- e) Price bid of only those firms will be opened who score more than 60 marks. If no bidding firm gets the minimum 60 marks then the top three firms shall be taken into consideration for financial bid. If there are only one / two firms, then firms not meeting the qualifying marks may be considered.
- f) In case price bids of two or more firms are similar, then selection will be made on technical marks.
- g) In case price bids and technical marks of two or more firms are similar, the selection of that firm will be made which has more experience of auditing as stated above.

11. Minimum Recommended Scale of Fees as per ICAI norms

The minimum yearly fees per year for all funds is Rs. 75,000/-. Exclusive of G.S.T.
