## **TERMS & CONDITIONS OF THIS TENDERS/ORDERS BEING PLACED.**

1. **Rate:** The rate offered and ordered shall be FIRM inclusive of all **GST( GOODS & SERVICE TAXES)** as applicable mobilization/transportation/freight charges, loading unloading of materials, Insurance etc. ie.inclusive of all taxes and no charges extra over this rate shall be payable.
2. **Security Deposite & Agreement :-** Within 10 days from the date of issue of contract order, the successful tenderer shall execute an agreement (on stamp paper worth Rs.250/- and affixing revenue stamp worth Rs.1/-)with the order placing authority of CSPDCL after making a deposit as **Security Deposit equivalent to 5% value** of the contract order value towards for the due and proper fulfillment of the contract performance guarantee & settlement of liabilities if any against the contract. Both these security deposits shall be crossed (Account Payee)MICR pay order or Demand Drafts payable to **The R.A.O. C.S.P.D.C.L. Jagdalpur** (cheque shall not be accepted). FDR from a Nationalised/Scheduled bank pleaded in favour of the **The R.A.O. C.S.P.D.C.L. Jagdalpur** and execute an agreement on the prescribed form duly stamped. The cost of stamp paper for agreement including cost of revenue stamps shall be borne by the contractor. The Security deposit towards performance guarantee shall be valid up to 6 months from date of completion of work. The amount will be retained as the security for the due and proper fulfillment of the contract as well as settlement of liabilities if any against the contract. No interest shall be payable by CSPDCL for Security Deposit.
3. **Penalty For Delay In Completion Of Contract:** - The Penalty towards delay in completion of the work completion shall be 0.5% of total value of the order per week subject to a maximum of 10% . The earnest money deposited by the successful tenderer shall be forfeited if the tenderer fails to furnish security deposit & execute the agreement or start any work for which contract awarded within such time as may be determined by the S.E (CIRCLE) Jagdalpur , after intimation of the acceptance of his tender. This forfeiture shall be without any prejudice to the right of recover further damage, if any from the tenderer on whom contracts(s) awarded.
4. **Payment:** Normally the payment shall be made by the company's payment authority within one month from the date of completion as certified **by E.E. PROJECT Dn. CSPDCL Jagdapur & E.E. (PROJECT) Dn. CSPDCL Dantewada** and submission of the bill in quardruplicates. No interest shall be paid on delayed payment.
5. **Safety measures.:** The Chartered Accountant would be responsible for Safe handling of documents handed over to him for Auditing.

## **IMPORTANT NOTES**

1. Tender submitted with condition (S) other than as stipulated in this tender shall be summarily rejected.

2. In case of extension of due date of opening of tender, the tenders already submitted will be retained by this office. However the bidders who have already submitted the bids, will be allowed to submit fresh price bids (only part –III) in a plain paper mentioning the rates (in words and figures), in a sealed envelope mentioning, the reference of tender specification no, which should be submitted in this office within stipulated time and date, both original and subsequent fresh offers will be opened on the extended due date of opening and the lowest of the two will only be considered. In case fresh offer is not received, the original offer will be considered.”
3. Quoting same rates, i.e pool rate is not acceptable. In case the same rate is found to be quoted by more than two bidders, offers of all such bidders shall be outrightly rejected. However, if rates of two bidders are found to be same then the orders will be placed to them by reducing to half of the quantity a bidder is entitled to be allocated by virtue of their common rank.
4. Before submitting the tender, tenderer shall be deemed to have full knowledge of all relevant documents and to have satisfied himself by actual inspection of the site and locality of work, all the conditions liable to be encountered during the execution of the works are taken into account and that the rate he enters in the tender forms are adequate and all inclusive to accord with the provisions of general/special conditions of contract for the completion of the work to the satisfaction of the Engineer-in –charge E.E. PROJECT Dn. CSPDCL Jagdapur & E.E. (PROJECT) Dn. CSPDCL Dantewada Information about works given in bidding document is purely tentative and may change during actual execution as per site requirement. The bidder is advised to visit and examine the site(s) of work and their surroundings and obtain himself, at his own risk & cost all information that may be necessary for preparing the bid and entering into a contract for the works(s). CSPDCL will not entertain any claim at any stage from the bidder on the plea of having him not acquainted sufficiently to the site condition.
