DRDA, Jagatsinghpur invites "Expression of Interest" from reputed and experienced Odisha based Chartered Accountant Firms empanelled with C & AG for the F.Y 2020-21 for conducting audit of Accounts of 4 nos of Blocks of Jagatsinghpur District i.e Jagatsinghpur, Kujanga, Raghunathpur & Tirtol Block for the Financial Year 2020-21, 2019-20 & 2018-19.

The engagement of Chartered Accountant Firms shall be through two bid systems i.e. Technical Bid & Financial Bid. The Technically qualified Chartered accountant firms will eligible to participate in the Financial Bid. EOI along with all the documents can be submitted by the interested firms through **Speed Post/ Registered Post** only to "Project Director, District Rural Development Agency, Jagatsinghpur At-Sanara, Po-Nalibar, Dist-Jagatsinghpur, Pin-754104, Odisha". The firm should submit their Technical & Financial Bid in two separate envelopes & both the envelopes are to be packed inside one sealed envelope indicating "Technical Proposal" & "Financial Proposal" on top of the respective envelopes. The outer envelope is to be superscripted with **"EXPRESSION OF INTEREST FOR ENGAGEMENT OF CHARTERED ACCOUNTANT FIRM FOR CONDUCTING AUDIT OF ACCOUNTS OF 4 NOS. OF BLOCKS OF JAGATSINGHPUR, DISTRICT FOR THE F.Y 2020-21, 2019-20 & 2018-19."**

DRDA, Jagatsinghpur invites Expression of Interest from Odisha based Chartered Accountant firms empanelled with C & AG for F.Y 2020-21 for conducting Audit of Accounts of 4 nos. of Blocks of Jagatsinghpur District i.e Jagatsinghpur, Kujanga, Raghunathpur & Tirtol for the Financial Year 2020-21, 2019-20 & 2018-19.

The Chartered Accountant firm should submit their offer in the prescribed format mentioned below. Tender paper along with tender paper cost of Rs 500/- (Rupees Five hundred) (non-refundable) and EMD worth Rs 3000/- (Rupees Three thousand) only in shape of Demand Draft drawn in favour of PD, DRDA, Jagatsinghpur payable at Jagatsinghpur must be submitted with the Expression of Interest. The Expression of Interest without the cost of tender paper and EMD are summarily rejected by the Agency.

**Scope of Work & Terms of Reference**

1. Chartered Accountant Firm shall conduct 100% checking of vouchers relating to transactions, and other relevant records, documents, Books of Accounts of 4 nos. of Blocks of Jagatsinghpur District i.e Jagatsinghpur, Kujanga, Raghunathpur & Tirtol for the Financial Year 2020-21, 2019-20 & 2018-19 .
2. Firm will prepare analysis of Opening and Closing Balance taking unadjusted advances given to different categories of employees and funds position in different Banks/Post Offices/PL account.
3. Firm will ensure that all the financial transactions are recorded in Cash Book and reflected in Pass Book.
4. Firm will reconcile all scheme wise Bank accounts and ledgers.
5. Firm will ensure the correctness of accounts and may suggest necessary action points as per their requirements.
6. The Audit Firm will have to start the audit within 15 days of the receipt of the letter of appointment from DRDA, Jagatsinghpur.
7. No TA/DA expenses will be borne by the Blocks for the Chartered Accountant firms undertaking audit work and this will be met by the Audit firms.
8. The successful bidder shall not be entitled to claim any additional amount for any reason whatsoever for the above audit work.
9. Firms selected by DRDA, Jagatsinghpur shall have to give an undertaking to follow all ethics of faith and the information provided by DRDA, Jagatsinghpur/Blocks shall be kept 'strictly confidential' and all assignments shall be carried out with due diligence maintaining quality of work done and in the least possible time.
10. If the selected/engaged Chartered Accountant firm does not confirm the offer within the stipulated time, the committee may cancel their selection/engagement & opt for 2<sup>nd</sup> lowest bidder with L1 cost.

11. In case of any dispute, the decision of Collector-Cum-CEO, DRDA, Jagatsinghpur shall be final and binding.
12. After completion of the assigned work, the firm shall mandatorily give their overall findings/ views/ suggestions/ comments etc. for proper maintenance of accounts adopting Govt Financial Rule.

**TIME SCHEDULE**

The selected firm should submit the year wise & scheme wise Audit Report to DRDA & Block within 60 working days from the date of agreement.

**REGULATION OF AUDIT FEES**

1. The firm those are interested to be appointed will have to quote audit fees per Block per year. Firms quoting less than Rs.8, 240/-(Rupees Eight thousand two hundred forty) only per Block per Year will be out rightly rejected by the Tender-cum-Selection Committee.
2. No price escalation will be allowed during the engagement period.

The payment of Audit Fees will be made only after completion of Audit Work and issue of final Audit Report. Completion of Audit will include conduct of audit, submission of report and discussion thereof with the DRDA/Block. The Block will not pay any advance to the selected audit firm under any circumstances. Bill for Audit Fees will be submitted to Concerned Block Development Officer along with a certificate indicating that audit has been conducted as per guidelines framed by the Agency and the work has been completed as per the agreed terms and conditions.

**PRE-QUALIFICATION CRITERIA OF THE CHARTERED ACCOUNTANT FIRM**

The Chartered Accountant firm satisfying following eligibility criteria can bid only for conducting Audit of accounts of Blocks.

1. Should be empanelled with C & AG for the year 2020-21.
2. Must not have been blacklisted. An undertaking to this effect is to be submitted by the Chartered Accountant firm.
3. Must have minimum two partners. Single proprietorship firms are not eligible for participation.
4. The Chartered Accountant firm must have a minimum Average annual turnover of Rs.10.00 lakh (Rupees Ten lakh) only or more for the last 3 preceding financial years.
5. Must registered with Institute of Chartered Accountant of India and have Income Tax PAN and GST Registration.

The selected Chartered Accountant firm should submit authenticated documents of the followings:

1. Copy of partnership deed.
2. Copy of last 3 years Balance Sheet. (Profit & Loss A/C)
3. An undertaking to the effect that the firm has not been Black listed by any Govt./PSU Institutions.



4. An undertaking to the effect that no person of the Firm/partner is related to any employer of the concerned authorities/institutions nor have any interest in their activities.
  5. Firms profile indicating previous 3 years (Three) experience in undertaking similar work in any Govt Deptt/ Institutions and success story, if any, in streamlining financial management through their assigned work.
- B) - The audit team for conduct of audit at Block must comprise of one audit manager & two audit staff.
- The audit manager must be a CA qualified at least 3years of post qualification post
  - The audit staff must have 3 years of audit experience in similar nature of work.

**SUBMISSION OF BID**

i) **Annexure-A** :- Pre-qualification-Cum-Technical Bid with all the requisite documents duly signed with seal of the authorized partner of the firm should be submitted with separate sealed envelope superscribed as "PRE-QUALIFICATION-Cum-TECHNICAL BID".

ii) **Annexure-B** :- Financial Bid duly filled and signed with seal of the authorized partner of the firm should be submitted with separate sealed envelope superscribed as "FINANCIAL BID".



OF BLOCKS OF JAGATSINGHPUR, DISTRICT FOR THE F.Y 2020-21, 2019-20 & 2018-19**".

iv) The EOI duly filled must be submitted through **Registered Post/Speed Post** only to DRDA, Jagatsinghpur. Any EOI received after due date will be out rightly rejected. DRDA Jagatsinghpur will not be responsible for any postal delay or misplacement of the document.

v) The authority reserves the right to accept or reject any or all the offers received or cancel the bidding process at any stage prior to award of contract and without assigning any reason thereof.

**OPENING OF BID & SELECTION OF CHARTERED ACCOUNTANT FIRM**

- a) After opening of Technical Bid, the CA firm who fulfilled all above necessary conditions will be considered as technically qualified and only after that the Financial Bid of the same firm will be opened.
- b) The lowest bidder may be considered as selected firm for Block Audit.
- c) More than one Chartered Accountant firm can be engaged for audit of Block accounts and selection & distribution of Block among the Chartered Accountant firm will depend upon the decision of Tender committee.
