Request for expression of interest for concurrent auditor

(A) Brief Profile

BSBCL is a Government of Bihar undertaking corporation created under the aegis of Registration, Excise and Prohibition Department Government of Bihar. The formation of BSBCL was approved by the Cabinet on 25th March 2006. BSBCL has been incorporated under the Companies Act 1956. Corporation started its operation from 1st October 2006. After the imposition of liquor Prohibition in the state of Bihar, BSBCL has been now engaged in the following activities:-

To provide, encourage, initiate facilities for the discovering and promoting Prohibition of Alcoholism and Substance (Drugs). The aims and objectives of the present Scheme for Prevention of Alcoholism and Substance (Drugs) Abuse are: -

- (i) to create awareness and educating the people about the ill-efforts of alcoholism and substance abuse on the individual, the family and the society at large; to evolve culture specific models for the prevention of alcoholism and substance and the treatment and rehabilitation of addicts;
- (ii) to provide/ promote for the whole range of community based services for the identification, motivation, counseling, de-addiction, after-care and rehabilitation of addicts;
- (iii) to promote/ provide collective initiatives and self-help endeavors among individuals and groups vulnerable to addiction or found at risk; to establish appropriate linkage between State interventions and voluntary efforts in the field of prohibition of alcoholism and substance abuse prevention;
- (iv) to increase community participation and public cooperation in the reduction of demand for dependence-producing substances; and

EOI has been invited from interested CA firms to carry out concurrent audit of Bihar State Beverages Co. Ltd. For the year 2022-23. Scope of Work, Eligibility criteria and submission & evaluation details are as follows-

(B) Scope of Work:-

- Firms would carry out concurrent audit through an Auditor as per the provisions of Companies Act 2013, Provision of Bihar Financial Rules, Income Tax Act 1961 & Goods and Services Act 2017.
- 2. Audit would cover entire operation of BSBCL.
- 3. The concurrent audit will be done by the Chartered Accountant firm through its authorized representative deputed by the selected firm.

- 4. Authorized representative so deputed by the CA firm will be semi qualified having minimum educational qualification of Inter CA with one year experience.
- 5. The Partner/Proprietor of the CA firm will have to be available at BSBCL office during office hour on once a week.
- 6. The authorized representative will have to be available at BSBCL office during office hour on all working days.
- 7. CA firm, while submitting monthly bill, will also submit certified attendance of the representative.
- 8. Representative of CA firm deputed at office of the BSBCL, will not be replaced without prior consent of the BSBCL.
- 9. The Auditor should have the knowledge of Bihar Financial Rules, Corporate Law, GST Act & Income Tax Act.
- 10. The term of the contract may be extended, in case the services of the firm are found to be satisfactory.
- 11. In case, the services of the representative of CA firm is found unsatisfactory by the management of Bihar State Beverages Co. Ltd. the CA firm shall replace him/her within seven says of receiving such request form Bihar State Beverages Co. Ltd.
- 12. At the end of each month, selected CA firm will submit a monthly report incorporating its observation/irregularities found and corrected.

(C) Eligibility Criteria:-

- 1. Firm should Head office/Branch in Patna.
- 2. Firm should be empanelled with CAG (Copy of empanelment should be attached).
- 3. Firm should be registered with ICAI with minimum 5 year of existence (Copy of registration should be attached)
- 4. Firm should have income tax, PAN and GST registration number. (Copy of registration should be attached)
- 5. The CA firm should have minimum 3 year of experience of auditing Government Departments/Government Board/Government Corporation/Government Society. (Copy of registration should be attached)

(D) General:-

- The selected firm will not sublet the assignment to any other CA firm/s or individual chartered accountant. If such practice is found, the society will be at liberty to remove the assigned or individual and blacklist the firm.
- 2. The technical committee of the BSBCL will scrutinize the applications and firm will be selected on the basis of fulfillment of the minimum eligibility criteria.
- 3. The Corporation will have the right to cancel any application and/or postpone the process of selection at any stage without assigning any reason there of.
