I. Background

National Centre for Earth Science Studies (NCESS) is an autonomous institution under the Ministry of Earth Sciences, Government of India. It is a society registered under The XII Travancore Cochin Literary, Scientific and Charitable Societies Act 1955. The affairs of the society are managed, administered, directed and controlled by the Ministry of Earth Sciences.

- 1. As per the bye-laws of the Society, the Accounts of the NCESS shall be audited by a Chartered Accountant firm to be appointed by the Governing Council of NCESS.
- 2. The Financial statements are prepared on mercantile system of accounting followed by going concern concept, except for the External/Consultancy Projects which are accounted on cash basis.
- 3. During the financial year 2022-23, the accounting activities were carried out in Fox-Pro based customized accounting software.
- 4. NCESS receives grants-in-aid of approximately Rs. 30 Crores per annum from the Ministry and other external sources. The Centre incurs expenditure at an average transactions of 2000 Debit Vouchers, 750 Credit Vouchers and 750 Journal Vouchers.

II. Audit Fees

The minimum amount of Audit fees for aforesaid assignment shall be Rs.40,000/- plus GST. The quotes below this will not be considered for evaluation and awarding of contract. No TA/ DA / accommodation or out of pocket expenses shall be paid in addition to fees assigned.

III. Other General Terms and conditions
