1. INTRODUCTION

Tourism Corporation of Gujarat Limited is a Company completely belonging to Government of Gujarat established under Companies Act, 1956. This Corporation was established in the year 1975 and the Corporation started its commercial work from 1977-78. The Corporation undertakes commercial and promotional activities for development of tourism industry as Nodal Agency of State Government. As per Audited Report for the financial year 2023-24 the financial detail of the Corporation is as under:

2. SCOPE OF WORK:

a) The firm shall be required to be well conversant with the procedure, policies, rules and regulations of the Corporation.

- b) Internal Audit on quarterly basis for all branches (Unit/ TIB) including Head Office of the Corporation shall be conducted and its quarterly report shall be sent in One copy to the Managing Director, TCGL, Gandhinagar.
- c) Under Pre-audit system, pre-audit of vouchers for payment of more than Rs. 5,000/- of the Corporation shall be conducted at Head Office of the Corporation during all working days.
 - All office working day the "Pre audit" will be conducted by experience person who have completed CA/Inter CA both Group as per the institute of chartered accountant of India and with have fully knowledge of GST Act 2017 and other all law of Income Tax. (Internship or running article ship student will be disallow for Pre-Audit)
 - The pre-audit office hours will be the same as the regular office hours.
 - Must be declare Pre-Audit team with Minimum 3 member and submit along with certificate of article ship and work of Experience
 - 1) Senior Chartered Accountant as Pre-Audit Team Leader who will review the Pre-Audit work every week.
 - 2) Chartered Accountant having knowledge of GST, Income Tax, other fiscal laws etc.
 - 3) The Pre-Audit shall be conducted with coordination of our Audit and Finance Branch.

Remark: Member of the above Audit team cannot change without prior approval of TCGL Audit Branch. Penalty of Rs. 500 per day can be imposed on Firmor any person who contravenes to any of the conditions of the tender and specifically, the EMD will be forfeited after one notice.

- **d)** Accounts shall be get audited by Statutory Auditor and Internal auditors work shall be coordinated with Statutory Auditor as per requirement.
- **e)** All ancillary works shall be carried out until annual accounts are passed in Audit Committee/Board of Directors and Annual General Meeting.
- f) When any opinion is sought with respect to any item of Account/Audit of Corporation, it shall be provided after verification of requisite record.
- g) All financial records of relevant unit should be maintained and need to prepared and submit Financial Statements of all Units Shown in Table-2 except Gandhinagar HO.
- h) Besides above work, any work relating to Internal Audit shall be carried out by you.

3. ELIGIBILITY CRITERIA:

- a) The CA Firm must have Head Office in Gujarat or in case of no Head Office in Gujarat, the Firm shall have at least 3 Full Time Branch Offices in Gujarat at least for 3 years as on 31/03/2024.
- b) The existence of CA Firm should have minimum 10 years as on 31.03.2024.
- c) The CA Firm must have minimum 3 Chartered Accountants including 2 Full Time Partners.
- d) The CA Firm must have minimum staff strength of 20 peoples on regular pay roll.
- e) The CA Firm should have minimum Annual Turnover of Rs. 30 Lacs in each of last 3 financial years.
- f) The CA Firm must have experience of at least 10 Internal/Statutory Audit Assignments of PSUs/Local Authorities during last 5 years.
- g) The CA Firm must have empanelled with C & AG for Major Audit of PSUs.

- h) The CA Firm which has conducted Internal Audit during last 3 years of the Corporation shall not be considered for Internal Audit assignment.
- i) The CA Firm should be firm with a valid Permanent Account Number (PAN) and GST Registration. (Copy to be submitted)
- j) The CA Firm should not have been debarred/blacklisted by any State Government/Central Government/PSU for any reason in the last three financial years as on bid calling date. (Self-declaration of the same to be given)

4. EVALUATION OF ELIGIBILITY CRITERIA:

5. SELECTION OF BIDDER / AUDITOR:

The Price bids of only technically qualified bidders will be opened for further consideration. The Final selection /Appointment of CA Firm will be done as under:

- (a) On opening of Financial Bid online, the shortlisted bidders will be given weighted Average total score which will be determined as under:
 - (i.) 80% weightage will be given to Technical Score.
 - (ii.) 20% weightage will be given to Financial Score.
 - (iii.) Weighted Average Total score = (0.80*Technical score) +(0.20*Financial score)
- (b) Financial score of the bidder will be determined as per below mentioned Formula:

Financial score=Lowest Bid amount/Price quoted by respective bidder*100.

- (c) The shortlisted bidders will be ranked according to total score (Technical Score and financial score).
- (d) The bidder having highest total score will be selected.

- (e) In case, same quotes by more than 1 Bidder(s), the preference will be given to the Firm/LLP having Highest turnover and experience in Govt. Sector for Internal Audit or Pre-Audit.
- (f) If there is a tie between two or more bidders, negotiation will be allowed as the following step in the appointment process.

TCGL reserves the right to reject the Offer of Bidder(s) quoting below reserve price. The Decision of Management of Tourism Corporation of Gujarat Ltd will be final on any issue on interpretation of any of the documents of this tender.

6. DURATION OF ASSIGNMENT:

This tender will be valid for the financial year 2025-26. However, considering satisfactory work, the appointment may be extended for One year with mutual consent. The Corporation reserves the right to extend the tenure or terminate the appointment on account of unsatisfactory performance.

7. MINIMUM PROFESSIONAL FEES:

The minimum Professional fees will be Rs 15 Lacs (Excluding GST).

8. PAYMENT TERMS:

- a) No advance payment will be made.
- b) Payment will be made on quarterly basis.
- c) All the payments shall be released on receipt of Quarterly Internal Audit Report and after due verification by Tourism Corporation of Gujarat Ltd.
