#### 1. Generic

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

#### 4. Forms of EMD and PBG

4. Initially the contract will be for a period of two years which will be extendable for six months depending upon the satisfactory performance of the CA Firm.

5. Payment will be released on quarterly basis. TDS will be deducted as per rule from the bill.

6. An undertaking that the Agency/company/firm is not blacklisted by any Govt. Department.

7. The Director, ICMR-NIREH may terminate the contract of the selected firm by giving a notice of one mon

th.

8. The selected firm shall have to enter into an agreement before work and submit a performance security of 3% of the contract value.

9. The rates should be quoted in two parts:

(a) Lump sum per month for activities mentioned in scope of work at point no. A, B, C and D.

(b) Lump sum for activity mentioned in scope of work at point no E.

10. The bidders are requested to not merge the prices of 9(a) and 9 (b). As the work mentioned in 9(b) is o n requirement basis for which letter/email will be issued by the office separately.

11. If any bidder is quoted the combined prices for work 9(a) and 9(b) mentioned, the bid is liable to be rej ected.

# **SCOPE OF WORK**

## <u>A.</u> <u>Work related to Income Tax TDS</u>

1. To ensure compliance of timely E-filing of all the returns pertaining to Income Tax-TDS including e-filing of monthly, quarterly TDS returns pertaining to Income Tax deducted from salaries (24Q) and TDS deducted from contractors (26Q).

2. Feeding of data of Income Tax deduction of employees/contractors.

3. Data for filing aforesaid return will be provided by ICMR-NIREH through soft/ hard copy as required.

4. To ensure timely generation of Form-16, 16-A or any other document mandatory required under aforesaid activities.

5. Timely filing of correction/rectification/revision in monthly/quarterly returns in case of any incorrect entry or invalid/wrong PANs /GST Numbers or any other kind of error in any return of Income Tax-TDS.

6. Appearing before the Income Tax/GST Authorities on case to case and providing assistance to file reply of Notice of Income Tax-TDS, GST-TDS and GST matters as and when required.

7. In ICMR-NIREH, there are approximately tentative 110 number of regular staff for which 24Q quarterly returns is to be filed and Form 16 are to be generated after the end of the FY. Approximately 20 numbers of contractors for which 26Q quarterly returns are to be filed.

8. Any other work related to Income Tax which is not explicitly mentioned in the scope of work or may be introduced by the Government due to changes in the Taxation laws etc. will form the part of the scope of work.

9. Any other work related to Income Tax as assigned by ICMR-NIREH whether or not it pertains to the period of engagement of the firm/consultant.

10. Visit of the consultant/authorised staff once or more in a month to guide on Income Tax related matters. No TA/DA etc. will be paid for this.

## B. Work related to GST Matters
