05. The service provider firm has to execute contract agreement in the pre scribed pro-forma and the agreement shall be initially executed for 36 months a t their cost. 15. Prasar Bharati, Bhopal reserves the right to reject bid of the firm whose per formance at on-going supply is below par and usually poor and has been issued letter of restrain/Temporary/Permanent debar by any office of Prasar Bharati, G overnment or Public sector. (Rule 151, GFR 2017) Prasar Bharati, Bhopal reserv es the right to verify the credential submitted by the agency at any stage (befor e or after the award of the work). If at any stage, any information /documents submitted by the applicant are found to be incorrect/false or have some discrep ancy which disqualifies the firm then Prasar Bharati, Bhopal shall take the follow ing action:

17. 19. The Bidder is not put on 'Holiday' by any of the organization of Prasar Bhar ati or any of the Government departments, Public Sector or banned/blacklisted by Government department/Public Sector on the due date of submission of bid. The Bid submitted by such Bidder shall not be considered for opening/ evaluatio n/ award and in case of Manual Tendering, such Bid along with the Bid Security, if any, will be returned immediately to the Bidder.

22. **FORFEITURE OF EMD:** The earnest money deposited by the Bidder shall be forfeited by Prasar Bharati in the following events:

Failure on the part of the successful Bidder/Contra ctor to sign the 'Agreement' within the above stipulated period, shall c onstitute sufficient grounds for appropriate action as per Tender provisions.
- (c) If the Bidder or any employee of the Bidder or any person acting on be half of the Bidder, either directly or indirectly, is a relative of any of th e employee of Prasar Bharati, or alternatively, if any relative of an em ployee of Prasar Bharati has financial interest/stake in the Bidder's fir m, the same shall be disclosed by the Bidder at the time of filing of ten der in **Annexure-8**. The term 'relative' for this purpose would be as d efined in Companies Act amended from time to time.
- (d)The Bidder shall not lend to or borrow any money from or enter into an y monetary dealings or transactions, directly or indirectly, with any em ployee of Prasar Bharati.

# 24. EMPLOYMENT BY BIDDER FIRMS TO OFFICIALS OF THIS ORGANISA TION:

Firms/companies who have or had business relations with the Organisatio n are advised not to employ serving employees of this Organisation without its prior permission or within the initial one year period after the retirement/resign ation/severance from the service without specific permission of this Organisatio n. This Organisation may decide not to deal with such firms who failed to compl y with the above advice.

### 25. CANCELLATION /RESCISSION:

The Bidder shall be liable to pay compensation for any loss to Prasar Bhar ati, Bhopal resulting from any cancellation/rescission due to the reasons attribut able to the Bidder and the Prasar Bharati, Bhopal shall be entitled to deduct the amount so payable from the amount due to the Bidder.

## 26. **REJECTION**

If the ORGANISATION finds that the services supplied are not in accordan ce with the specification and other condition stated in the order (of which matt ers this Organisation will be the sole judge), this Organisation shall be entitled t o reject the whole of the services or the part, as the case may be, and intimate to the supplier/contractor the rejection without prejudice to the Organisation's o ther rights and remedies to recover from the supplier any loss which the ORGA NISATION may be put to, also reserving the right to forfeit the security deposit/ performance bond, if any, made for the due fulfillment of the contract. The servi ces shall be removed by the supplier/contractor and if not removed within 14 da ys of the date of communication of the rejection, the Organisation will be entitle d to dispose-off the same on account and at the risk of the supplier/contractor a nd after recovering the loss and expense for restoring the services, if any cause d to the Organisation, pay balance to the supplier/contractor.

# 27. FAILURE AND TERMINATION CLAUSE

Time and date of delivery of services shall be the essence of the contract. If the supplier/contractor fails to deliver the services there of, within the period f ixed for such delivery in the schedule or at any time repudiates the contract bef ore the expiry of such periods, the Purchaser may, without prejudice to any othe r right or remedy available to him to recover damages for breach of the contrac t.

#### 28. Liquidated Damages-

28 (a) The Service user will recover from the successful bidder a liquidat ed damage, in case of breach of any terms & conditions mentioned in the Bid D ocument attributable to the service provider. The main default clauses are detai led below:-

If the services are not provided to the Prasar Bharati, Bhopal within the sti

pulated time period, then the organization reserves the right to hire services fro m any other alternative source at the prevailing market rates and the ledger ac count of the service provider will be debited for differential cost of making altern ative arrangement (if any), in addition to liquidated damages. The liquidated da mage for each return will be @ Rs. 5000/-. However, liquidated damages shall n ot in any case be higher than the contract value.

If the Selected Service Provider is on regular defaults for none providing o f services, the Liquidated Damages equitant to the Performance Security can be imposed and simultaneously contract may be cancelled.

28 (b) Prasar Bharati reserves the right to cancel the contract or a portion thereof by serving prior notice to the supplier/contractor and if so desired purch ase or authorize the purchase of the services not delivered not carried out or ot hers of a similar description (where stores not delivered not carried out, exactly complying with particulars are not in the opinion of the purchaser, which shall b e final, readily procurable) at the risk and cost of the supplier/contractor. If the s upplier/contractor had defaulted in the performance of the original contract, the purchaser shall have the right to ignore his bid for risk purchase even though th e lowest. Where the contract is terminated at the risk and cost of the firm under the provisions of this clause, it shall be at the discretion of the purchaser to exe rcise his discretion to collect on not, the Security Deposit from the firm on who m the contract is placed, at the risk and expense of the defaulted firm

28 (c) Where action is taken under sub-clause 26(b) above the supplier/co ntractor shall be liable for any loss which the purchaser may sustain on that acc ount, provided the purchase or if there is an agreement to purchase, such agree ment is made in case of failure to deliver the services, within 6 months from the date of such failure and in case of repudiation of contract the supplier/contracto r shall not be entitled to any gain on such the entire discretion of the purchaser to serve a notice of such purchase on the contractor.

#### 29. SUBLETTING AND ASSIGNMENT

The contractor shall not sublet, transfer or assign the contract or any part thereof or interest therein or benefit or advantage thereof in any manner whats oever, without the previous consent in writing of the purchase Authority, provid ed nevertheless that any such consent shall not relieve the contractor from any obligation, duty or responsibility under the contract.

#### **30. FORCE MAJEURE**

(a) If any time during the continuance of the contract the performance in whole or in part by the Successful Bidder shall be prevented or delayed by reason of any war, hostility acts of the public enemy, civil commotion, sabotage, fir e, floods, explosions, epidemics, Quarantine restriction, strikes, lock-outs or act s of god, (but not including negligence or wrong-doing, predictable/seasonal rain) here-in after refer to as events and provided notice of happenings of any suc

h eventuality is given by the successful Bidder in writing within 07 days from th e date of occurrence thereof (and it cannot be claimed ex-post facto), the purch aser shall by reason of such event, neither cancel this order nor shall claim for d amages against the contractor in respect of such non-performance or delay in p erformance and delivery shall be resumed as soon as practicable after such eve nts have come to an end or ceased to exist. However, if such event continues fo r a period exceeding 90 days, either party may at its option terminate the contr act by giving notice to the other party.

(b) If the timelines are not met by force majeure conditions lasting for more than 90 days, the organization have the option of cancelling this contract i n whole or part at its discretion without any liability on its part of the Purchaser.

## 31. FALL CLAUSE

31.1 The price for the services/works under the contract/Supply order by t he contractor/Supplier shall in no event exceed the lowest price at which suppli er/contractor or his agent/principal/dealer as the case may be, sells the services /works or offers to sell services/works of identical description to any persons/org anizations including the purchaser or any department of the Central Govt. or an y Deptt. of State Govt. or any Statutory undertaking of the Central or State Govt., as the case may be, during the contract period.

31.2 If at any time, during the said period, the contractor/supplier or his a gent/principal/ dealer as the case may be, reduce the sales price, sells or offers to sell such services/works to any persons/organizations including the purchaser or any Department of Central Govt. of any Department of a State Govt. or any st atutory undertaking of the Central or State Govt. as the case may be, at a price lower than the price chargeable under the contract/supply order, he shall forth with notify such reduction or sale or offer of sale to the Purchase Authority who has issued this contract/supply order and price payable under the contract/supp ly order for the services rendered/works carried out after the date of coming int o force of such reduction shall stand correspondingly reduced. The contractor/s upplier shall furnish the following certificate to the concerned Purchaser as per **Annexure-15**.

32. Bidder is required to submit declaration regarding Holiday / Banning and L iquidation, Court Receivership certificate as per annexed **Annexure -6**.

33. Bidder is required to submit past supplies certificate as per **Annexure-11**.

34. Technical Bid must contain scanned copy of Unconditional Acceptance of P rasar Bharati's Tender Terms & Conditions.

35. Performance security @3% of contract value in the form of the DD/Bank Gua rantee/Hypothecated FDR valid for the period of 60 days beyond contract agree ment period has to be deposited by the bidder finalized on the basis of the lowe st rates and fulfilling the essential terms and conditions. 44. In case of any litigation, jurisdiction of court will be Bhopal.

45. LANGUAGE/TERMINOLOGY: The supplier/contractor shall ensure the langua ge/terminology/description of services used in supply order/bill of lading/Invoice any other documents dispatched by the supplier is verbatim in English.
