## **About National Farmers Welfare Program Implementation Society (NFWPIS)**

The National Farmers Welfare Program Implementation Society (NFWPIS) registered under Society registration act, 1860, under the administrative control of Ministry of Agriculture & Farmers Welfare, New Delhi. The office of the NFWPIS is operational at 4<sup>th</sup> (Half) & 6<sup>th</sup> Floor, Plant Authority Bhawan (PAB), PUSA, New Delhi-110012.

## 2. Objective:

The National Farmers Welfare Program Implementation Society (NFWPIS), invites bids from authorized Companies/ Firms or Individuals specialized for carrying out the Secretarial Matter and Internal Audit related work of NFWPIS for FY 2025-26, 2026-27 and 2027-28 of NFWPIS.

Bidders are requested to go through the details of Tender Process, Scope of Works and Terms & Conditions etc. as indicated in this RFP to be followed before quoting their best offer along with the complete details and documents required under this RFP.

## 3. Terms & Conditions for Hiring CAG-Empanelled Auditor

## I. Eligibility Criteria

- i. The auditor must be empanelled with the Comptroller and Auditor General (CAG) of India.
- ii. The firm must have at least one full-time FCA (Fellow Chartered Accountant) partner.
- iii. The auditor must comply with the Companies Act, 2013 and other relevant statutory provisions.
- iv. The firm must have an operational office or branch located in Delhi/NCR.

#### II. Scope of Work

- i. Prepare the accounting statement of the society as per requirement of management.
- ii. Prepare final account of the society for the relevant Financial Year.
- iii. Conduct internal audit of the transactions of the society and issue necessary advisory to the management for improvement of the accounting system.
- iv. Evaluate Internal control mechanism of the organisation and make recommendations for improvement.

- v. Identify shortfall and gaps in the processes and report the same to the management.
- vi. Conduct financial audits as per the prescribed standards.
- vii. Ensure compliance with accounting and regulatory frameworks.

## C. Bidder's queries & Clarifications

- a. NFWPIS shall invite queries from Bidders as per the details mentioned in the Fact Sheet of this document.
- b. The Bidders will have to ensure that their queries for reach to NFWPIS by email with in 7 days of floating of RFP mentioned in Fact Sheet of this document. The queries should be sent at email mentioned herein. The queries should necessarily be submitted in the following format:

- c. NFWPIS shall not be responsible for ensuring that the Bidder's queries have been received by them. Any requests for clarifications post the indicated date and time may not be entertained by the NFWPIS.
- d. The purpose of query clarification is to provide the Bidders with information regarding the RFP, project requirements, and opportunity to seek clarification regarding any aspect of the RFP and the project. However, NFWPIS reserves the right to hold or re-schedule the Pre-Bid meeting.

## D. Responses to Pre-bid Queries and Issue of Corrigendum

- a. The Officer notified by the NFWPIS will endeavour to provide timely response to the queries. However, NFWPIS makes no representation or warranty as to the completeness or accuracy of any response made in good faith, nor does NFWPIS undertake to answer all the queries that have been posed by the Bidders.
- b. At any time prior to the last date for receipt of bids, NFWPIS may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the RFP Document by a corrigendum.
- c. The Corrigendum (if any) & clarifications to the queries from all Bidders will be uploaded on the GeM portal.
- d. Any such corrigendum shall be deemed to be incorporated into this RFP.
- e. In order to provide prospective Bidders reasonable time for taking the corrigendum into account, NFWPIS may, at its discretion, extend the last date for the receipt of Proposals.

## E. Key Requirements of the Bid - Rights to terminate the process:

- a. The NFWPIS may terminate the RFP process at any time and without assigning any reason. The NFWPIS makes no commitment, express or implied, that this process will result in a business transaction with anyone.
- b. This RFP does not constitute an offer by the NFWPIS The Bidders' participation in this process may result in the NFWPIS selecting the Bidder to engage towards execution of the Contract.

#### F. Proposal Preparation Costs

The Bidder shall be responsible for all costs incurred in connection with participation in the RFP process, including, but not limited to, costs incurred in conduct of informative and other diligence activities, participation in meetings / discussions / presentations, preparation of Proposal, in providing any additional information required by NFWPIS to facilitate the evaluation process, and in negotiating a definitive Contract or all such activities related to the bid process. NFWPIS will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

#### G. Submission of RFP

a. Not more than one RFP offer will be accepted from any Bidder. If an Individual / Bidder participates in the RFP offer, representing more than one bid by one Organization / Individual under one or different name then such multitude of bid

shall amount to collusive activity and appropriate action should be taken by the NFWPIS under fraud and corrupt practices.

- b. RFP offers have to be submitted through the GeM portal.
- c. The offer should be given in the prescribed format as per this RFP document.
- d. The submission of offer by any Bidder implies that they have read the terms and conditions of the RFP and have made themselves fully aware of the scope and specifications of the requirement. Any addition or omissions in the original offer after opening of the offers will not be entertained.
- e. Bidders to submit the bids with covering letter which may be seen at Appendix-I.

#### H. Deadline for Submission of the Bids

- a. The bids should be received through the GeM portal before or on scheduled date & time.
- b. NFWPIS reserves the rights to extend the deadline or for making any other change in the Bid document by issuing an amendment online in this regard.

#### Evaluation Process

- a. NFWPIS will constitute a Tender Committee to evaluate the responses of the Bidders.
- b. The Tender Committee constituted by the NFWPIS shall evaluate the responses to the RFP and all supporting documents / documentary evidence. Inability to submit requisite supporting documents / documentary evidence, may lead to rejection.
- c. The decision of the Tender Committee in the evaluation of responses to the RFP shall be final. No correspondence will be entertained outside the process of evaluation with the Committee.
- d. The Tender Committee may ask for meetings with the Bidders to seek clarifications on their Proposals.
- e. The Tender Committee reserves the right to reject any or all Proposals based on any deviations.
- f. Each of the responses shall be evaluated as per the criterions and requirements specified in this RFP under the 'Eligibility Criteria', 'Instruction to Bidders' and 'Evaluation and Selection' section

## J. Deciding Award of Contract

- a. The NFWPIS reserves the right to ask for a technical elaboration / clarification in the form of a technical presentation from the Bidder on the already submitted Technical Proposal at any point of time before opening the Financial Proposal. The Bidder shall furnish the required information to NFWPIS and its appointed representative on the date asked for, at no cost to the NFWPIS.
- b. NFWPIS may inform those Bidders whose Proposals did not meet the eligibility criteria or were considered non-responsive, informing that their Financial Proposals will be not opened after completing the selection process NFWPIS shall simultaneously notify those Bidders who qualify for the Evaluation process as described in this Document, informing the date and time set for opening of Financial Proposals. The notification may be sent by mail.
- c. After acceptance of Letter of Acceptance (LOA), Performance Bank Guarantee shall be deposited as specified in this document for signing an Agreement with NFWPIS.
- d. Special Condition for Awarding the Agreement:
- i. NFWPIS will sign the Agreement with Successful Bidder for a period as mentioned in 'Duration of Contract' in the document.
- ii. NFWPIS will also have the right to increase or decrease the scope of work as per the mutually agreed terms and conditions between both the parties.

## K. Limitation of Liability

The selected Bidder's maximum aggregate liability to the NFWPIS (Client) under or in connection with any Order under this RFP or any collateral contract, whether arising from negligence, breach of contract, tort, breach of statutory duty, indemnity or otherwise shall not in the aggregate exceed the charges paid to selected Bidder for the Services in respect of the Order in question and in respect of this Agreement shall be limited to the total amount of the charges paid to selected Bidder for Services. Nothing in this or Agreement arising out of this tender shall exclude or in any way limit either party's liability to the other for fraud or fraudulent misrepresentation (to the extent such an exclusion is not permitted death or personal injury caused by negligence or that of its employees, directors, partners, agents or subcontractors any liability to the extent that the same may not be excluded or limited as a matter of law. The Client (and any others for whom Services are provided) shall not recover from the selected Bidder, in contract or tort, including indemnification obligations under this contract, under

statute or otherwise, aggregate damages in excess of the fees actually paid for the Services that directly caused the loss in connection with claims arising out of this Agreement or otherwise relating to the Services.

## L. Termination Clause

NFWPIS may, without prejudice to any other remedy for breach of contract, by a written notice of default of at least seven days sent to the selected Bidder, terminate the Contract in
